

# Frieze Los Angeles 2023 Car Park Ticket Terms and Conditions

## GENERAL TERMS

1. Frieze Los Angeles (“Fair” or “Event”) is organized and managed by Frieze Events Inc (“Organizer”), a company incorporated in the United States with company number 4966861 and with registered office at 247 Centre Street, 5<sup>th</sup> floor, New York NY 10013, USA.
2. Frieze Los Angeles is held at Santa Monica Airport and the Barker Hangar (the “Venue”).
3. By purchasing a Car Park ticket to the Fair, you (“You”) agree to be bound by the terms and conditions set out herein (“Terms and Conditions”), the [Website Terms of Use](#) and such other terms as are drawn to the attention of visitors by the Organizer and those detailed on the Ticket.
4. These Terms and Conditions shall be governed by and construed in accordance with the laws of the State of California without regard to its conflict of laws principles that require another State’s law to apply. Any claim arising under this Agreement shall be prosecuted in a federal or state court of competent jurisdiction located within Los Angeles County, California.
5. If any of these Terms and Conditions should be determined to be illegal, invalid or otherwise unenforceable by reason of the law of any state or country in which these Terms and Conditions are intended to be effective, then to the extent and within the jurisdiction in which that term or condition is illegal, invalid or unenforceable, it shall be severed and deleted from that term and the remaining Terms and Conditions shall survive and continue to be binding and enforceable.
6. To the extent permitted in law, any cause of action a Ticket holder may have with respect to their Ticket must be commenced within one (1) year after the claim or cause of action arises.
7. The Organizer expressly reserves the right to change and/or amend these Terms and Conditions from time to time.

## PURCHASE CONDITIONS

8. Car Park Tickets allow entry to the car park from 30 minutes before the entry time stated on your Admission Ticket and no later than the entry time stated on your Admission Ticket. Please ensure You arrive on time. Latecomers will not be admitted into the car park.
9. Visitors will not be allowed admission into the car park without a valid Car Park Ticket.
10. Visitors who have not purchased a Car Park Ticket online in advance will not be authorized to park in the car park.
11. The Organizer does not allow re-admission into the car park.
12. Car Park Tickets are only available to purchase in advance online and will not

be available to purchase at the Venue.

13. Car Park Tickets do not grant admission to the Fair. Admission Tickets to the Fair must be bought separately.

14. All Car Park Ticket sales are final and unless otherwise stated herein, no refunds, cancellations or exchanges are available after a Ticket has been purchased.

15. Car Park Tickets must not be resold, exchanged, transferred, altered or defaced. Any such action shall render the Ticket(s) void (and any individual with such a Ticket may be refused entry or removed from the fair in the Organizer's sole discretion).
