## WHO WE ARE

## **OUR SERVICE AND YOUR DATA**

All Data is processed in accordance with applicable data protection legislation and we will keep your personal information only for as long as is necessary.

#### COOKIES

We use cookies (i.e. small text files which are transferred to your browser by our websites) to identify data traffic patterns, personalise contents and support security. The cookies we use are described in more detail in our **cookie statement**. They do not provide any information that directly discloses the identity of a specific person but they may potentially identify your computer, your browser and your internet settings. You may change the storing of cookies in your browser settings at any time by selecting the function "accept no cookies". However,

We may use Facebook pixels on our pages. Pixels are lines of code placed on our website to help us track conversions from Facebook ads, optimise ads based on collected data, and build targeted audiences,
