COVID-19 (coronavirus) PROTOCOLS AND ENTRY CONDITIONS

1. The Organizer reserves the right to set health and safety policies and procedures to govern the Event, which may be set and updated by the Organizer from time to time in its sole discretion. By purchasing a ticket and/or enter the Event, all visitors agree to comply with the current health and safety policy posted by the Organizer. Organizer policies may include, without limitation, requirement for all visitors aged 2 and over to provide one of the following:

- a. **Proof of full course COVID-19 vaccination** completed at least fourteen (14) days prior to such person's entry to the Event venue; or
- b. Proof of a **negative PCR/molecular** equivalent test result obtained within 2 days before your visit; or
- c. Proof of a **negative Rapid Antigen** test result obtained within 1 day before your visit;

Visitors aged 18 and over must also provide appropriate **photo identification** matching the name on the test result or vaccination proof. In addition, all visitors ages 2 and over shall wear a **medical-grade face mask** which shall cover the individual's nose and mouth at all times (unless eating or drinking) while in the Event venue.

2. It is Your, and all ticket holder's responsibility to arrange all testing and/or vaccinations at appropriate times and arrive to the event with relevant proof. Entry will be refused if valid proof is not provided on arrival. Refunds will not be given to ticket buyers who fail to comply with entry requirements.

3. For the avoidance of doubt, Organizer reserves the right to modify the required documents and protocols in accordance with applicable laws, rules, regulations, ordinances, and guidelines in place at the time of the Event.

4. An inherent risk of exposure to COVID-19 (coronavirus) exists in any public place where people are present. COVID-19 is a contagious disease that can lead to severe illness and death. By purchasing or otherwise accepting a ticket to the fair, You are acknowledging that an inherent risk of exposure to COVID-19 exists in any public place where people are present. By attending the Fair, You and any guests voluntarily assume all risks related to exposure to COVID-19 and agree not to hold the Organizers, venue management, and/or venue owners liable for any illness or injury in connection with your or your guests' attendance at the Fair.

5. By purchasing a ticket to the Fair, You and any guests agree that You are not to attend or travel to the Fair should any of the following be applicable on the day of your visit;

- You are experiencing any known symptoms of COVID-19 including; a fever (temperature above 100.4 degrees Fahrenheit), chills, repeated shaking with chills, shortness of breath or difficulty breathing, a new and continuous cough, sore throat, muscle pain, headache, new loss of taste or smell, nausea, vomiting or diarrhoea
- You have had close contact (more than 15 minutes / under 6 feet distance) with someone who was exhibiting COVID-19 or flu-like symptoms, was recently diagnosed with or tested positive for COVID-19, or was under self-quarantine due to exposure or potential exposure to COVID-19
- You have been directed to self-isolate by a public health authority any time in the past fourteen (14) days.
